Slate Declaration Form

IMPORTANT NOTE: The term slate means any grouping by mutual consent of two or more candidates. All candidates desiring to form a Slate MUST use t his form. Read the Instructions and Explanation below. Then turn to the reverse side for the actual Declarations of Affiliation with a Slate.

Instructions And Explanation

Each candidate is permitted to run for any delegate, alternate delegate or International Officer position as a member of a slate of candidates, regardless of whether the slate is complete. No candidate shall be compelled to run as a member of a slate, nor shall any candidate be permitted to run on more than one slate.

To form a slate, there shall be mutual consent between and among all candidates running on the slate. Such mutual consent shall be evidenced by the signing of a declaration by all members of the slate giving the position that each candidate seeks and the name, if any, of the slate to be formed. Amended slate declarations may be submitted adding additional candidates, provided that the deadlines specified immediately below are met.

In the case of delegate nominations and elections, such declarations shall be filed no later than three (3) days after the Local Union's final delegate nominations meeting, and in the case of International Officer nominations and elections, such declarations shall be filed at the earliest possible date but in no case later than August 31, 2016.

International Officer Slate Declaration Forms must include the designation of a treasurer for the slate. The slate treasurer must be a member of the Union but need not be a candidate.

Once a candidate declares his or her intent to run as a member of a slate, he or she may not retract such declaration.

Should one or more members of a slate be found ineligible to run, such an ineligibility shall not affect the remaining members of the slate.

For more information, see Article VIII of the Rules for the 2015-2016 IBT International Union Delegate and Officer Election ("Rules").

For delegate elections, this form must be submitted to the Local Secretary-Treasurer with a copy to the Election Supervisor. In the case of international officer candidates, the Slate Declaration Form shall be submitted to the Election Supervisor, who may be contacted at:
